FREQUENTLY ASKED QUESTIONS

1. When is Orica's AGM?

Orica's 2021 Annual General Meeting ('AGM' or 'Meeting') will be held at 10.30am (Melbourne time) on Thursday, 16 December 2021. You will be able to register on the day from 10.00am at <https://meetings.linkgroup.com/ORI21>.

2. Why is Orica not holding a physical meeting this year?

To address the ongoing health concerns and uncertainties presented by the COVID-19 pandemic, our AGM will again be held virtually (online).

The Board values the AGM as an opportunity to engage with shareholders in person each year. As this will not be possible for the 2021 AGM, you are strongly encouraged to attend, register and ask questions relevant to the business of the Meeting using the online platform.

3. What technology do I need to attend the virtual AGM?

You can access the virtual AGM using a desktop computer or a mobile device connected to the internet. To attend, vote and ask questions at the virtual AGM you must have your Securityholder Reference Number (SRN) or Holder Identification Number (HIN) and your postcode (or country code if you are outside Australia).

You may also listen to the AGM and submit questions by phone. Instructions can be found in the Virtual Meeting Online Guide available at orica.com/agm2021.

4. What if I voted before the AGM? Can I still attend?

Yes, you can login to the virtual AGM from 10.00am (AEDT) on Thursday, 16 December 2021 at <https://meetings.linkgroup.com/ORI21>. You do not need to register for a Voting Card if you have previously voted. However, if you wish to ask a question you will need to register with your SRN/HIN to submit a question. Please refer to the Virtual Meeting Online Guide for details on how to submit a question.

5. What if I hold my shares jointly?

If you hold your shares jointly, you and the other holders may attend the virtual Meeting and ask a question. However, if more than one joint holder votes during the Meeting, only the vote of the holder named first in the register will be accepted.

6. Can I submit a question in advance of the AGM?

Yes. You can submit a question by email to investorrelations@orica.com. Questions must be submitted by 5.00pm (Melbourne time) on Thursday, 9 December 2021.

7. Why have you not mailed a Notice of Meeting or Voting Form? How will I lodge my vote before the Meeting?

Similar to last year, consistent with the relief provided by the Federal Treasurer, and to reduce costs and environmental impact, Orica will not be mailing shareholders a hard copy Notice of Meeting or a Voting Form.

If you currently receive our shareholder communications electronically, you will have received an email on 16 November 2021 following the release of the Notice of Meeting. This email will include your personalised shareholder link to vote online.

If you currently receive your shareholder communications by mail, you are able to lodge a direct or proxy vote on the resolutions using the orange 'Investor Login' button at linkmarketservices.com.au. You will need to enter your SRN or HIN and postcode (or country code if outside Australia).

8. What are the deadlines for voting and submitting questions before the Meeting?

Direct and proxy votes must be submitted online at linkmarketservices.com.au by 10.30am (Melbourne time) on Tuesday, 14 December 2021.

Questions must be submitted to investorrelations@orica.com by 5.00pm (Melbourne time) on Thursday, 9 December 2021.

9. What is the latest time I can login to vote at the virtual AGM if I miss the pre-meeting registration?

You can login at any time during the course of the Meeting at <https://meetings.linkgroup.com/ORI21> and register for a Voting Card. There will be a five minute warning prior to the close of voting for shareholders to submit their votes.

If you are unable to attend the virtual AGM, a recording of the webcast will be available to view after the meeting at orica.com/agm2021.

10. Can visitors attend the virtual AGM?

Visitors are welcome to log in to the virtual Meeting and listen to the live webcast. However, only registered shareholders will be able to vote or ask a question.

11. Where do I get help if needed during the virtual AGM?

Before the meeting, please refer to the Virtual Meeting Online Guide available at orica.com/2020agm. If you require further assistance during the Meeting, please call the telephone number displayed on the screen and Link Market Services staff will be available to assist you.

12. Where can I locate my SRN/HIN?

This will be displayed on your new shareholder welcome letter or other documentation you received when you first became an Orica shareholder. If you are unable to locate your SRN or HIN, please contact Orica's share registry, Link Market Services, on 1300 301 253.
